Subject:- Constitution of Committee regarding modernization of DGMS.

With the approval of Competent Authority, a Technical Committee is constituted to examine and go through the existing functions and role of DGMS and suggest ways and means for modernization of DGMS as per following compositions:-

2. The terms of reference of the Committee are as under:-

- to go through the role and functions of DGMS Officers / Inspector cum Facilitators, and assess their required role and functions as per National / International scenario;
- to examine, analyse as to how the accident rates in Mines can be reduced to minimum with a proposed revised robust modernised DGMS;
- to develop a mechanism for "remote" regular Inspections/Surveillance by

DGMS;

- iv. to develop a differential Inspection/Surveillance mechanism for DGMS in respect of mines of different categories and scales.
- v. to develop a mechanism for reduction in need of physical Inspections done by DGMS and at the same time improve effectiveness, quality and accuracy of the Inspections.
- vi. to recommend and suggest ways and means as to how auto-compliance of law by the Industry can be ensured without inspection need of DGMS;
- vii. to recommend and suggest "State of the Art" Gadgets, technologies, and systems for DGMS's Inspections, monitoring and allied functions.
- viii. to suggest mechanism and means to use Satellite/Lidar and other latest technologies for Surveillance /Inspections.
- ix. Status and Standard of training needs of persons employed in Mines and availability of skilled manpower.
- x. Status and Standard of Medical examination vis –a– vis health surveillance of workers employed in Mines.
- xi. Status and Standard of Rescue Services in respect of all categories of Mines (Underground, Opencast Coal/Metal Mine and Oil Mines).
- xii. Any other term to be added by the Committee members by consensus.

3. The Committee will come up with a detailed report including the recommendations and a clear Blue-print for effective modernisation of DGMS in line with the latest technologies and submit its report within a time period of 2 months. In case of non-official members, TA / DA will be reimbursed by DGMS as per existing instructions issued by Ministry of Finance from time to time.
